



Scholarship Application

Every child should have the opportunity to take music lessons. Heywood Music Studios, LLC offers scholarships and work study programs to help make that happen. We have joined through a partnership with the MusicLink Foundation to offer financial assistance to families. Also, through a partnership with Wisconsin Foundation for School Music and the Steinway Piano Society, The Steinway Piano Society will place pianos from the Piano Bank in the home of qualified children in order to provide a quality instrument for practice and performance while taking piano lessons (need based, and student/applicant must make a pledge to regularly attend lessons and practice daily).

In order to properly process your application, please provide the following items:

1. Fully completed scholarship form with all information
2. Current 1040 Income Tax Return (please copy in its entirety)
3. Last two years W-2 forms
4. Social Security statement (if applicable)

There will be a total of one financial scholarship and one performance scholarship available per academic year. Financial aid scholarships are available for students who qualify for free or reduced price lunch program at school. Performance scholarships are based on a student audition before a panel of judges. Contact the studio for information on scholarship standards for homeschoolers.

Student/parent interviews will be held as part of the application process for financial and performance scholarships. Performance applicants must schedule an audition as part of the application process. A part of the requirement will be the student must commit to daily practicing (not be overcommitted to after school activities) and participate in performance opportunities.

Students that are selected to receive a scholarship will be given 25% off regular tuition rates from January 1 to June 10th. Recipients will be eligible to re-apply for the summer and fall sessions. Students receiving the financial scholarship will have assistance with tuition as stated above and books and music. Scholarships are only for use at Heywood Music Studios for private lessons to be determined by the studio schedule and director.

Scholarships are available for: i)all instruments instruction offered at Heywood Music Studios; ii)students in grades 1-12.

Families will be contacted for scheduling an interview/audition once the completed application has been processed. All information on the application will be held in strictest confidence. Scholarship application deadline is November 30th.
